TERMS & CONDITIONS

1. SSBEC Bursary Application is open only to members whose children who are currently studying in local government education institutions pursuing their Primary, Secondary, ITE, Pre-U, JC, Polytechnic or University. This bursary is **not applicable for private or overseas** education Institutes.
2. Members who have **submitted their resignation to cease their membership with SSBEC** do not qualify to apply.
3. Children who have received any Bursary Awards from other organizations are not eligible to apply.
4. The gross monthly **Per Capita Income (PCI) of less than or equal to \$2,250.**
5. Only **1 Bursary Award shall be given per family** (household). Bursary Recipient (student) must collect their Bursary Award in person during the Bursary Awards, failing which the Bursary will be forfeited.
6. Members' children who are **16 years old & above** must enrol as a member and activate their Subscription savings of **\$10** with SSBEC Co-op. Monthly contribution can be through children own GIRO or through the Ordinary member's account. The necessary documents must be provided for the membership enrolment activation.
7. Bursary Award recipient (student) who are members of SSBEC Co-op are not allowed to cease their membership 12mths upon receipt of Award.
8. Applications for Bursary must be attached with photocopies of:
 - a) Child's birth certificate;
 - b) Child's final examination results of 2024;
 - c) Latest payslip of member.
 - d) Latest payslip of family members residing in the same address
9. **For ITE, Pre-U / JC, Polytechnic, & University applicants** must submit a letter of confirmation of admission or acceptance from the relevant Institution together with the application form.
10. All documents submitted will be retained by the Co-op. Any applicant who fails to produce the relevant documents together with his/her application will not be considered.
11. The value of Bursary Awards and eligibility criteria for various levels are as follows:

Level of Education	Award	Eligibility Criteria
A) Primary 2 to 6	\$ 100.00	Passed/Admitted and studying in 2025
B) Sec 1 to Secondary 4	\$150.00	Passed / Admitted and studying in the Special, Express, Technical & Normal streams in 2025
C) ITE	\$200.00	Admitted and studying in ITE in 2025 after passing "N" or "O" level
D) Pre-U/JC/Poly	\$250.00	Passed "O" level & admitted and studying in 2025
E) University Level	\$350.00	Admitted and studying in NUS, NTU, SIT, SUTD, SUSS, SMU in 2025

12. Bursary application shall be from 27/01/2025. All application forms must be duly completed and **submitted no later than 15/03/2025** Applications received after **the closing date will not be accepted.**
13. **Only successful applicants** will be informed by email. Applicants who have been selected to receive the Bursary have to attend the Bursary Award ceremony to collect the Bursary. The decision of the management is final and no further correspondence shall be entertained before, during and after the Awards are granted.
