

# Membership perks with effect from 1st January 2025

# **MEMBER BIRTHDAY GIFT**

- Must be a member of SSBEC for at least 12 months and above
- Must have regular monthly contribution to subscription capital
- Need to provide NRIC Copy to claim the Birthday Gift
- Need to claim within 30 days in person at SSBEC office

#### **GET WELL SOON FRUIT BASKET**

- Only applicable to SSBEC members who are hospitalized in local hospital
- Must have regular monthly contribution to subscription capital for past 12 months
- Member or related party need to inform SSBEC on member admission with details of Hospital,
  Ward and Room number
- Fruit Basket will be sent to member based on information provided
- Member will only be able to receive 2 Fruit Baskets per calendar year (applicable to 2 admissions only)
- Hospital admission must be at least 24 hrs and above
- Must be claimed within 3 days of discharge

## **GIFT OF LOVE – BIRTH OF A NEW BABY**

- Only applicable to SSBEC members who give birth to a new baby
- Must have regular monthly contribution to subscription capital
- Member or related party need to inform SSBEC on detail upon member who have given birth to a new baby with details of Hospital, Ward and Room number.
- Hamper or Fruit Basket will be sent to member based on provided information
- Hospital admission must be 24 hrs and above
- Must be claimed within 3 days of discharge

## **DEEPEST CONDOLENCES – DEMISE OF A MEMBER**

- Only applicable to SSBEC members who have passed on
- Must have regular monthly contribution to subscription capital
- Member or related party need to inform SSBEC on the necessary details for SSBEC to send the Wreath to member.
- Wreath will be sent to the late member



#### **HOSPITALISATION CLAIM**

- Must be a member of SSBEC
- Admitted to Singapore hospitals
- Must submit Hospital admission and discharge summary for claim
- Must be warded and admitted for atleast 24hours
- Must be claimed within 2 months from date of discharge.
- Claims in accordance as follows: -

8 <sup>th</sup> Year & above	S\$ 900.00	15 Days

## **DEATH CLAIM**

- Must be a member of SSBEC for at least 1 year and above
- Must have regular monthly contribution to subscription capital
- Death certificate of deceased member must be submitted
- Claim to be made by nominees or immediate family members only
- Less than 8 years of membership: \$300 claimable (must have \$500 subscription balance)
- 8 years of membership & above: \$500 claimable (must have \$1,000 subscription balance)
- Must be claimed within 2 months
- Benefits are claimable by those who have completed a minimum of 12 months of membership and have consistently paid their monthly subscriptions for the past 12 months.
